<p>The DHLNMU is interested in the following forms of cooperation in the field of the academic mobility:</p> <ol style="list-style-type: none"> 1. Student mobility for studies or for traineeships (up to 10 students per project) 2. Staff mobility for teaching or for training (up to 10 staff per project) <p>The Capacity Building in Higher Education direction will include the creation and development of material and technical, medical, and research bases of the DHLNMU University Clinic for student training, patient treatment, and scientific research. The University Clinic will include the creation of the Rehabilitation Training Center for the professional training of doctors, interns, and students from the courses "Medical Rehabilitation," "Physical and Rehabilitation Medicine," and "Physiotherapy." Training staff in these specialties is a priority task of the Ukrainian healthcare system for rehabilitating military and civilian persons.</p> <p>The next element is providing modern diagnostics and equipment for the Center of Neurology at the University Clinic, which will enable the early diagnosis of neurological diseases (strokes, multiple sclerosis, epilepsy, dementia, and others) and significantly reduce the mortality rate, especially among vulnerable categories of the population. Employees of the surgery departments at DHLNMU need modern equipment to provide high-quality and effective medical care to numerous residents of the region and temporarily displaced persons from the war zone. Currently, the lack of high-quality medical equipment complicates operations and reduces the effectiveness of medical interventions. There is also a need to provide students with adequate opportunities to acquire surgical skills, which requires specialized surgical simulators to help them practice and improve their skills.</p> <p>A potential direction of cooperation is to update the Simulation Center for pediatrics, obstetrics and gynecology, and dentistry at DHLNMU. Training at the simulation center contributes to the continuous professional development of students, interns, and other healthcare professionals by helping them acquire modern practical skills, master the principles of teamwork, and follow current protocols and standards for providing medical care, ensuring maximum patient and medical staff safety.</p> <p>The University is also interested in potential scientific cooperation, particularly in the field of the history of medicine, especially the Austro-Hungarian period of the University's activity. These studies are actively carried out at the Department of Normal Anatomy, which houses a museum founded in 1894 by Henryk Karol Klemens Kadyi, a graduate of the University of Vienna and rector of the University of Lviv (1898—1899). The University's scientific activity can also extend to endocrinological studies of physiological and biochemical parameters in treating patients with post-traumatic stress disorder, as well as research in medicinal chemistry, specifically in searching for potential drug-like molecules with anticancer activity.</p>
