<p>The project "Innovators of the Future: Laboratory of Sustainable Development of Territories" is aimed at stimulating the economic development of territories through education, innovation and scientific research. The main goal of the project is to promote the development of local communities, increasing the level of economic literacy and supporting innovative initiatives among young people. The tasks of the project include the study and adaptation of the Austrian experience of integrating universities into local business ecosystems, the formation of educational programs aimed at the development of the local communities, providing practical opportunities for students through internships and partnerships with local businesses, as well as the development of infrastructure to support startups and entrepreneurial initiatives in communities.</p> <p>At the first stage it is planned to carry out a study of the Austrian model of university integration into the business ecosystem, an assessment of the current state of the local economy and the role of universities in it, as well as the development of a plan for the introduction of Austrian experience into the local context. The second stage involves the creation of courses and trainings on entrepreneurship and the development of the local economy, the introduction of dual education programs that combine theory and practice, and the support of student projects focused on local problems and opportunities.</p> <p>The project involves the creation of a virtual economic laboratory, which becomes a platform for modelling real economic situations and processes relevant for specific territories. Interactive research modules allow students to analyze local economic conditions and develop solutions aimed at improving the well-being of communities. Special attention is paid to creative marathons held with an emphasis on solving local economic problems. The project envisages the creation of an international research community that unites students, scientists and entrepreneurs to conduct joint research with an emphasis on the economic development of territories.</p> <p>The purpose of mobility to Austria is to study the experience of cooperation between Austrian universities and local communities with the aim of further implementation of successful practices in the Ukrainian context.
